### **GENERAL NOTE:**

**Entry points marked with an asterisk, thus \*, must be completed to avoid your application being delayed. Failure to complete will cause the Membership Secretary to carry out further investigations, even contacting you by telephone or mail, before processing.**

- NOTE 1.** Members Under 16 (Juniors) do not receive a Car Park/Access Gate Key as part of their Subscription. However, juniors may purchase key at the current price of £4.00 providing a letter from a parent giving consent for the member under 16 years of age to hold a key. Parent(s) must be aware that their child, once inside a locked facility cannot be freely reached should the need arise.
- NOTE 2.** Under current legislation to qualify for a Pensioner Concession, Ladies must be 60 years of age or over and gentlemen 65 years and over, The possession of a Concessionary Rod Licence is sufficient proof of eligibility.
- NOTE 3.** To qualify for the Concessionary Subscription for Disabled persons, sight either of a "Blue Badge" or a Concessionary Rod Licence is requested. Photocopies accepted..
